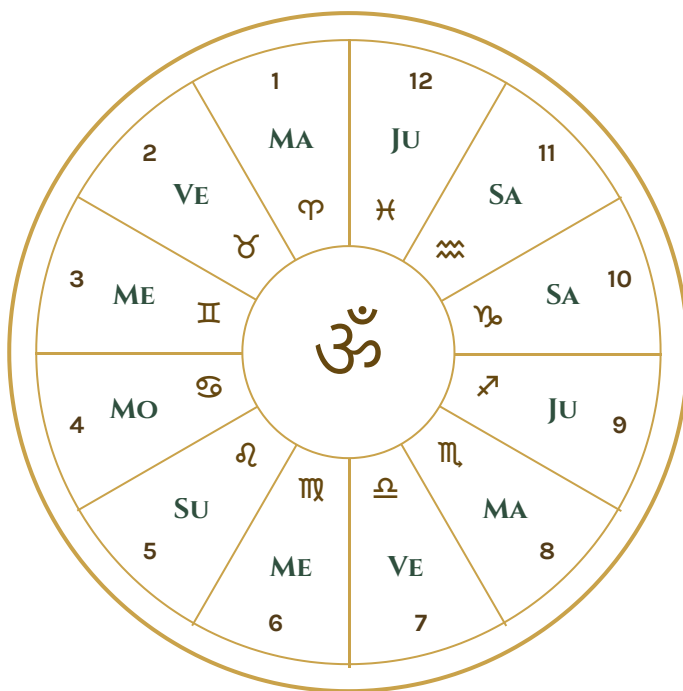

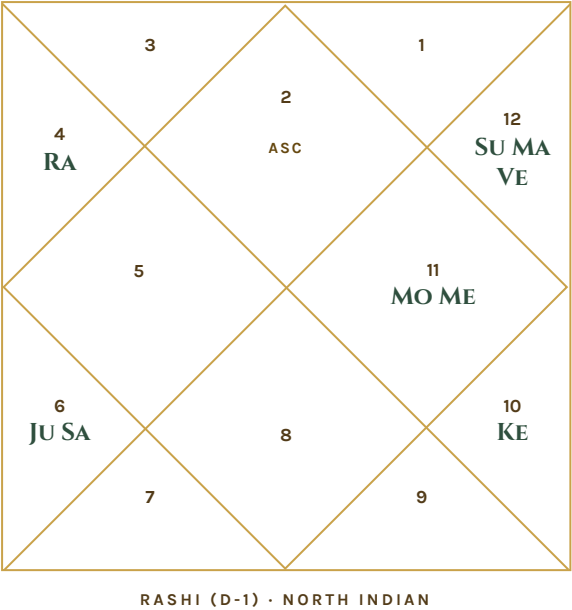

RASHI (D-1) - THE BIRTH CHART

The Rashi is the foundation chart, cast for the exact moment of birth. Every other divisional chart is derived from it, and every reading in this report begins here. The twelve compartments are the twelve houses in fixed positions, the Ascendant occupying the top-centre house; the small numeral in each house is its zodiac sign (1 = Aries ... 12 = Pisces).

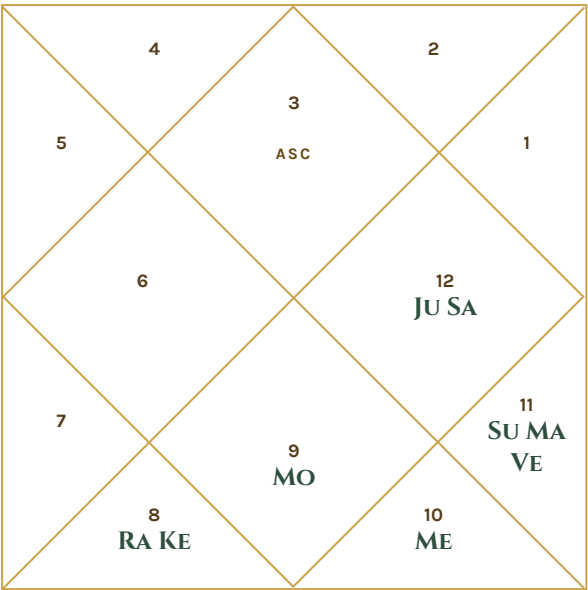

WHAT THIS CHART SAYS

- ◆ **Career and wealth are joined.** Mercury rules the 2nd and 5th and occupies the 10th, while the 10th lord Saturn occupies the 5th. The exchange makes expertise and intellectual property the main bridge to income.
- ◆ **Gains carry a personal signature.** Exalted Lagna lord Venus occupies the 11th with the Sun and Mars. Networks and public appeal can create strong gains, but combustion makes overextension the price to watch.
- ◆ **Communication is professional.** The Moon and Mercury occupy Aquarius in the 10th and Rahu occupies the 3rd. Public messaging, digital reach and audience response are central career tools.
- ◆ **Partnership needs limits.** The 7th lord Mars is combust in the 11th and fully aspected by Saturn. Clients can create gains, but equal ownership and shared liabilities need stronger protection than ordinary collaboration.

HORA (D-2) - THE WEALTH CHART

The Hora chart divides each sign into two halves and is read for wealth, earning capacity and the handling of money. This one follows the Uma-Shambhu variant, in which each sign's two halves are assigned across the zodiac rather than only to Cancer and Leo - so placements spread over several signs, unlike the two-sign Parashari hora.

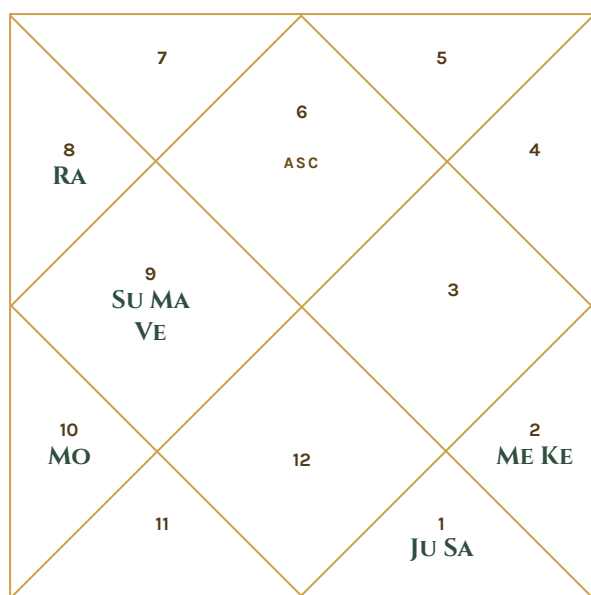

WHAT THIS CHART SAYS

- ◆ **Wealth must be managed actively.** The D-2 Lagna lord Mercury occupies the 8th, making cash management, reserves and tax-aware structure important. Money can grow, but passive handling is not supported.
- ◆ **Knowledge strengthens holdings.** Jupiter occupies its own Pisces in the D-2 10th with Saturn. Wealth-holding improves through long-term judgement, disciplined allocation and professional expertise.
- ◆ **Fortune supports multiple channels.** Sun, Mars and Venus occupy the D-2 9th. Income can benefit from visibility, enterprise and relationships, but the cluster also increases the need to separate personal desire from allocation decisions.
- ◆ **Shared-risk exposure is sensitive.** Mercury occupies the D-2 8th and the nodes occupy the 6th. Borrowing, taxes and joint obligations require documentation and contingency funds rather than informal trust.

NAVAMSA (D-9) - THE STRENGTH CHART

The Navamsa divides each sign into nine parts and tests whether a planet's Rashi promise has real backing. A planet dignified in both charts delivers durably; one strong in the Rashi but weak here tends to promise more than it delivers.

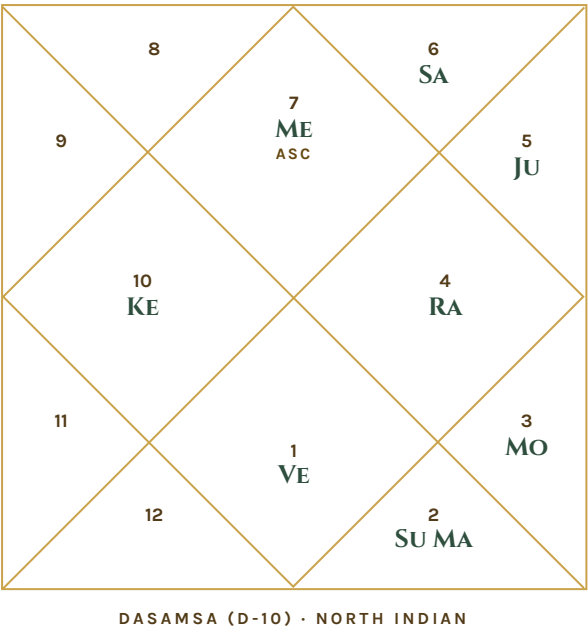

WHAT THIS CHART SAYS

- ◆ **Mercury holds up well.** Mercury moves to a friend's sign in the D-9 9th. The career value of communication and judgement strengthens with maturity and sustained study.
- ◆ **Creative planets receive support.** Sun, Mars and Venus occupy Sagittarius in the D-9 4th and receive Jupiter's aspect. Public expression becomes more coherent when it is anchored in a clear philosophy or body of knowledge.
- ◆ **Saturn needs maturity.** Saturn is debilitated in the D-9 8th with Jupiter. Career authority remains real, but it is tested through delays, reinvention and the need to release rigid control.
- ◆ **The career lord returns to Mercury.** The D-9 10th lord Mercury occupies the 9th. Professional success is reinforced by teaching, writing, travel, certification or a recognisable intellectual framework.

DASAMSA (D-10) - THE CAREER CHART

The Dasamsa magnifies the tenth house into a full chart of its own, showing the texture of professional life: the nature of authority, the workplace, and the source of rise. Where the Rashi shows the promise, the D-10 shows the delivery.

WHAT THIS CHART SAYS

- ◆ **Mercury defines the professional identity.** Mercury occupies the D-10 Lagna in a friend's sign. Communication, negotiation, analysis and intellectual ownership are visible parts of the professional persona.
- ◆ **Rahu drives the public career.** Rahu occupies the D-10 10th. The career rises through unconventional positioning, media, technology or a path that does not fit a standard institutional ladder.
- ◆ **Gains come through knowledge.** Jupiter occupies the D-10 11th in a friend's sign. Networks, teaching, advisory value and trusted communities support professional income.

PLANETARY STRENGTH (SHADBALA) SUMMARY

Relative strength of the career-significant planets, expressed as a percentage of required Shadbala strength. Shadbala measures strength, not outcome. Planets at or above 100% have the strength to deliver what their dignity, house and period allow; those below it deliver less consistently. Dignity, functional nature, planetary war and period context still govern the result.



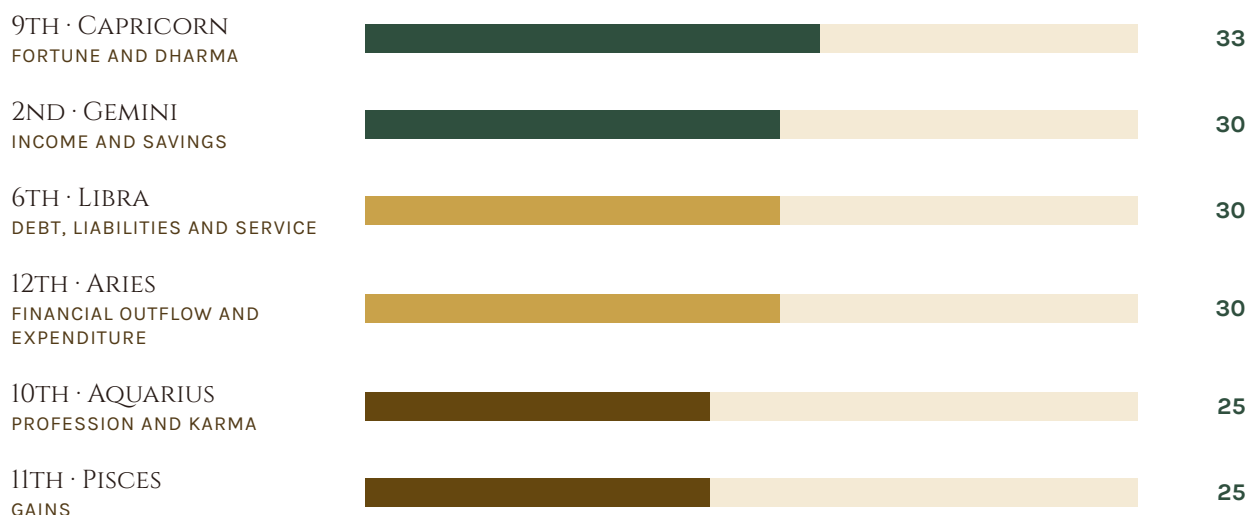
Vertical mark = 100% of required strength. Figures are the chart record's own Shadbala percentages (Sun 5, Saturn 5, Jupiter 6.5, Venus 5.5, Mercury 7, Mars 5, Moon 6 rupas required).

WHAT THIS MEANS

- ◆ The Sun is the strongest planet in the Career Strength Index at 144% and occupies the 11th. Visibility, leadership and asset-related decisions are genuine strengths when ego does not outrun evidence.
- ◆ Saturn stands at 115% and rules both the 9th and 10th houses. Professional durability comes from disciplined creative work, not from rushing the public result.
- ◆ Jupiter stands at 114% and rules the 11th from the 5th. Knowledge can create gains, but its great-enemy dignity makes careful selection more valuable than broad expansion.
- ◆ The Moon is the weakest planet in the Career Strength Index at 99% and sits in the 10th in an enemy sign. Public work remains important, but decision stability must be protected under pressure.

ASHTAKAVARGA - HOUSE STRENGTH SCORES

Sarvashtakavarga assigns each house a benefic-point score (out of a typical range of approximately 20 to 35, though individual houses can fall outside it). This report reads above 28 as supportive and below 25 as cautionary - a stated convention for this report, not a classical rule. The career-and-money houses are scored below.



Points out of 56 theoretical; 28 is the practical benchmark. Figures are this chart's own Sarvashtakavarga row (whole-sign houses from the Taurus Lagna).

WHAT THIS MEANS

- ◆ The 2nd house has 30 Sarvashtakavarga points, giving accumulated wealth a workable base. Saving improves when Mercury's career income is routed automatically rather than left to monthly intention.
- ◆ The 3rd house has 37 points, the strongest career-related score. Self-promotion, writing, speaking and direct distribution are more reliable growth levers than waiting for institutional sponsorship.
- ◆ The 10th and 11th houses each have 25 points. Career and gains can grow, but they need repetition, measurement and a strong operating system rather than dependence on applause or timing alone.
- ◆ The 5th house has 21 points, the lowest of the key career-finance houses. Creative and speculative decisions need testing, staged capital and evidence before scale.

SADE SATI & MAJOR TRANSIT ALERTS

Sade Sati - Saturn's passage over the natal Moon and the signs on either side of it - is the most consequential transit for career and finances. Every sign-boundary crossing of the cycle, retrograde re-crossings included, is listed below, together with the other major transits bearing on professional and financial matters.

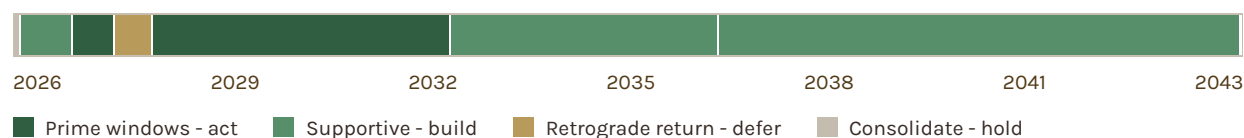

VARGA – A divisional chart; this report prints four - D-1, D-2, D-9 and D-10.

RASHI (D-1) – The main birth chart - every other chart is derived from it.

HORA (D-2) – The second divisional chart; read for wealth and earning.

NAVAMSA (D-9) – The ninth divisional chart; tests a planet's underlying strength.

DASAMSA (D-10) – The tenth divisional chart; the dedicated career chart.

VARGOTTAMA – A planet in the same sign in Rashi and Navamsa; extra durability.

EXALTATION / DEBILITATION – A planet's best (Uccha) and worst (Neecha) sign.

NEECHA BHANGA – Cancellation of debilitation, often reversing it into strength.

DURYOGA – The 10th lord in a dusthana - effort routed away from visible reward.

KENDRADHIPATI DOSHA – A convention-dependent condition in which a natural benefic owning only kendras may lose beneficence or turn functionally adverse; mixed lordships and exceptions depend on the school selected.

PRATYANTARDASHA – The third-level sub-period, inside an Antardasha.

SHANKHA – A yoga of the 5th and 6th lords in mutual kendras; long, stable standing.

KAHALA – A yoga of the 4th and 9th lords in mutual kendras; determination and command.

GURU-MANGALA – Jupiter conjunct Mars - energy applied to the house they share.

KEMADRUMA – A yoga of the isolated Moon; cancelled when a planet occupies a kendra from the Moon or Lagna.

TITHI – The lunar day - one of thirty in a lunar month.

PAKSHA – The lunar fortnight: Shukla waxing, Krishna waning.

VARNA – An Avakahada class based on the Moon sign; broad temperament.

VASHYA – An Avakahada class describing natural sway over others.

YONI – An Avakahada animal class read for instinctive compatibility.

GANA – An Avakahada temperament class: Deva, Manushya or Rakshasa.

NADI – An Avakahada constitutional class used in matching.

RINA – Debt - read from the 6th house.

VIDYA – Learning and formal education; the 5th and 9th houses.

DHARMA – Right action and life purpose; the 9th house.

SADHANA – Sustained personal practice.

SUKHA BHAVA – The 4th house - home, land, vehicles and comfort.

PRASHNA – A question put to the chart and answered from it.

SAHAYOGA – Partnership or collaboration.

SOOLA – One of the 27 daily yogas of the panchang; here the birth yoga.

MAHAKALA HORA – The planetary hour of birth in the Mahakala reckoning.

JANMA GHATIS – Time from sunrise to birth, measured in ghatas (24 minutes each).

AVASTHA – A graha's condition - the state it is in, which colours how it delivers.

BALADI – The age scale of avasthas: Baala, Kumara, Yuva, Vridhdha, Mrita.

JAGRADADI – The alertness scale: Jaagrita (awake), Swapna (dreaming) and Sushupta (asleep).

DEEPTADI – The mood scale of avasthas, from Deepta glowing to Duhkhita distressed.

SAYANADI – The activity scale of avasthas, from Sabha to Sayana (lying down).

TRIKONA – A trine house - the 1st, 5th and 9th; the fortunate angles.

DUSTHANA – A difficult house - the 6th, 8th or 12th.

DHANA BHAVA – The 2nd house - accumulated wealth and earning capacity.

DIGNITY – A graha's standing in the sign it occupies: own, exalted, friendly, neutral or debilitated.

DISPOSITOR – The lord of the sign a graha occupies; the chain of dispositors is considered when assessing yogas.

VESI – A graha other than the Moon in the 2nd house from the Sun.

BINDU – A benefic point in Ashtakavarga; the totals are counts of these.

PADA – A quarter of a nakshatra - 3°20' of arc.

SIDEREAL – Measured against the fixed stars, as Vedic astrology is - not the tropical seasons.

PARASHARI – The mainstream classical system, from the Brihat Parashara Hora Shastra.

JAIMINI – A parallel classical system using karakas and sign-based periods.

TAJIKA – The annual-chart system; a Varshaphal is cast within it.

PURNIMA – The full moon day.

AMAVASYA – The new moon day.

SHANI JAYANTI – Saturn's annual day, observed for Saturn propitiation.

GANDANTA – A sensitive junction between a water and a fire sign; timing around this junction may become sensitive.

BHUKTI – Another name for an Antardasha sub-period.

KAKSHA – A subdivision of a sign used in finer Ashtakavarga transit work.
